Dear Elgin Academy Friend,



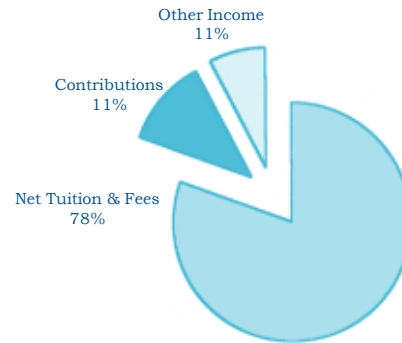

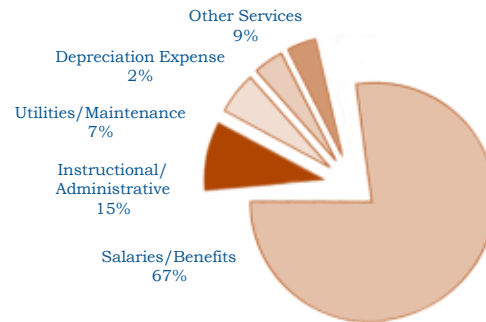
